

The well being of our customers and team members is our main priority.

Due to Covid 19 we have created a safe and comfortable environment for both our customers and team members therefore, there may be some minor changes to your usual Castle Carvery visit.

Everyone over the age of 11 must wear a face covering upon entry, exit and when not seated at a table.

We have increased our cleanliness and hygiene procedures. We have enhanced our regular cleaning regime to ensure that all surfaces and touch points are regularly cleaned and sanitised throughout the day, every day, and are deep cleaned daily.

Each individual table will be thoroughly cleaned and sanitised after each persons' visit and before the next persons' visit. Please always speak to a team member before you sit down at a table, even if the table looks like it is available.

We are currently operating with table service: a server will take your order from your table when you are seated.

You can still enjoy our delicious carvery by completing our carvery order form. You can choose your favourite succulent meats, locally sourced and freshly prepared vegetables, homemade Yorkshire puddings, alongside your choice of sauces, trimmings, and rich gravy.

Due to government guidance we can have a maximum of 6 people per table.

We are strongly encouraging customers to pay by contactless and card payments when possible, to avoid customers and our team members handling cash. The Contactless limit has now been increased to £45, we also accept Apple Pay.

To meet government advice, we have introduced new safe social distancing measures, which will be enforced throughout each restaurant. We kindly ask that you respect these measures during your visit, they are in place for your own safety and follow the current guidance.

To assist with the NHS Test & Trace system, please download the NHS Test & Trace app prior to your arrival and scan the QR Code to easily check in upon entry.

Children must be supervised and seated at all times to ensure the safe social distancing measures are followed.

Finally, for your own safety and our team members' safety, please do not visit our restaurants if you are unwell or have been in contact with anyone who has Covid-19 Symptoms.



The well being of adults, children and our team members within the FunFort is our main priority.

Due to Covid-19 there will be some minor changes to your usual FunFort visit.

Adults and children aged 11 and over are required to wear a face covering, except when eating and drinking or whilst in the play frame.

For the safety and enjoyment of children we are currently operating at a lower capacity, therefore, play sessions within the FunFort are limited to 90 minutes during peak periods. The FunFort opening times have been temporarily reduced to Saturday and Sunday from 12noon until 9pm.

We have increased our cleanliness and hygiene procedures using advanced cleaning equipment and products to ensure long lasting sanitation.

Adults and Children must sanitise their hands upon arrival and must maintain social distancing measures whilst in the FunFort. Please ensure that children stay 2 meters apart from other children who are not in their household, or bubble at all times.

Children must be supervised at all times to ensure the safe social distancing measures are followed.

For the safety of all children using the play area, destructive or disruptive behaviour is not allowed. We have a zero-tolerance policy, the management reserve the right to remove anyone behaving in an unacceptable manner.
